Special Purpose Grants Funding Preferences: Preference is given to non-profit organizations operating in and serving local communities. For this Fall session grants of up to \$1,000 will be awarded. We may not fully fund your grant request so, please seek other funding while waiting for our decision. The focus areas for grant distributions will assist local historical efforts on the part of historical entities. Grants should be for special projects and must be used by May 31, 2025. Examples of this are: speakers; education materials for project acquisitions that enhance content or the visitor's experience; fees for students to visit a museum; gas expenses for school bus transportation; registration costs for conferences and statewide meetings; and grants for professional development conferences and webinars.

Application Information and Deadlines: Submit the completed application with any supporting material including estimates for this grant by September 15, 2024. Grantees will be notified in October 2024.
